The adoption of the agenda was considered. McTighe made a motion to adopt the agenda. The motion was second by Irle. Motion passed.

The tourism director presented the WCVB 2017 annual report.

The floor was opened for discussion. The members present discussed increasing the lodging tax rate on a future ballot along with opportunities to help support Warrensburg's tourism.

Absent: Rhonda Gelbach, Cliff Gower, and Tom Koenigsfeld; and ex-officio members Danielle Johnston and Harold Stewart. (Gelbach joined at 3:10 p.m.)

The adoption of the agenda was considered. Irle made a motion to adopt the agenda. The motion was second by McTighe. Motion passed.

Minutes of the April 12, 2018 WCVB meeting were considered. Brunsvold made a motion to approve the meeting minutes with simple majority. The motion was second by Irle. The motion passed.

Minutes of the July 12, 2018 WCVB meeting were considered. Koenigsfeld made a motion to approve the meeting minutes. The motion was second by Gelbach. The motion passed.

Financial report provided by the WCVB director.

The RFP for financial institutions were presented by Rachel Denfeld, Finance Assistant with the City of Warrensburg. Ms. Denfeld distributed the summary chart showing Equity offering the highest rate of 2.45% and US Bank offering the lowest rate of 0.25%. Irle made the motion the WCVB accept the proposal from Equity Bank for financial services. The motion was second by McTighe. The motion passed.

The director presented the 2018-2019 budget for approval. Brunsvold made the motion the 2018-2019 budget be approved. The motion was second by McTighe. The motion passed.

The director provided an update on the RFP for professional photography services. No proposals were submitted. The RFP will be posted again in September following input from photographers in the area. The input will provide insight on why no submissions were received.

The chair asked for nominations to serve on the grant committee. The chair serves as ex-officio on all WCVB committees. Whitworth nominated Sandy Irle, Tom Koengisfeld and Rhonda Gelbach (alternate). The motion was second by Brunsvold. The motion passed.

The director presented the director's report. The board discussed moving the regular meeting time from 4 p.m. to 3:30 p.m. Date and location will remain the same. Board directed the director to change future meetings to 3:30 p.m. The director announced Cliff Gower had resigned and a replacement will be appointed at the City Council meeting on Monday, Aug. 27.

Lodging Tax Increase Ballot Initiative

During the joint meeting of the WCVB Board and City Council increasing the lodging tax rate was discussed. Diane Thompson, County Clerk and Election Authority was contacted for information regarding the election.

If the WCVB Board and City Council approve presenting the issue before the voters on the April 2019 General Municipal Election, the WCVB Board will need to approve at the November 8 WCVB Board meeting with the ordinance being presented to the City Council for approval at the December 10 meeting.

As per Diane Thompson, County Clerk and Election Authority, placing the issue on the ballot is estimated to cost \$2,100. The actual cost depends on the number of issues placed on the ballot.

Trails Update

During the joint meeting of the WCVB Board and City Council trails were discussed. The economic impact trails have on a community is significant. Communities that embrace trails have flourished.

The Spirit Trail on DD Highway connecting Warrensburg, Knob Noster and WAFB will be opening to the public soon. The ribbon cutting scheduled for Tuesday, Sept. 18 has been postponed. As per Bill Gable, there have been areas identified as needing attention prior to opening to the public. The trail from the Knob Noster State Park to the City of Knob Noster will be completed once approved by the state. It's estimated to cost \$3 million

The Spirit Trail Coalition's goal is to connect the Spirit Trail to existing trails (Katy Trail and Rock Island Spur). The coalition consists of representatives from Johnson County, City of Warrensburg, Knob Noster State Park, WAFB, Pioneer Trails Regional Planning Commission, and Johnson County bikers. The coalition meets the third Tuesday of the month. I will attend the monthly meetings and provide an update to the board in my director's report.
