**AN ORDINANCE CALLING AN ELECTION IN THE CITY OF WARRENSBURG, MISSOURI TO AUTHORIZE GENERAL OBLIGATION BONDS IN THE AMOUNT OF \$17,000,000 FOR STREET AND ROAD IMPROVEMENTS.**

**WHEREAS**, the City Council finds it necessary and hereby declares its intent to issue its general obligation bonds to acquire rights of way and to reconstruct and improve streets and roads (the "Projects") for the City.

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WARRENSBURG, MISSOURI, AS FOLLOWS:**

**Section 1.** An election is hereby ordered to be held in the City on April 6, 2021, on the following question:

**QUESTION**

**Shall the City Council of the City of Warrensburg, Missouri be authorized to issue general obligation bonds in the amount not to exceed \$17,000,000 to acquire rights of way, and to construct, reconstruct, extend and improve streets and roads in the City?**

**Section 2.** The form of the Notice of Election for said election, a copy of which is attached hereto and made a part hereof, is hereby approved.

**Section 3.** The City Clerk is hereby authorized and directed to notify the County Clerk of Johnson County, Missouri of the adoption of this Ordinance no later than 4:00 P.M. on January 26, 2021, and to include in said notification all of the terms and provisions required by Chapter 115 of the Revised Statutes of Missouri, as amended.

**Section 4.** The City may make expenditures on and after the date of adoption of this Ordinance in connection with the Projects, and the City intends to reimburse itself for such expenditures with the proceeds of the bonds. The maximum principal amount of the bonds expected to be issued for the Projects is \$17,000,000.

**Section 5. Effective Date.** This Ordinance shall take effect and be in full force from and after the date of its passage by the City Council and approval by the Mayor.
