ORDINANCE NO. 5395

AN ORDINANCE REPEALING CERTAIN PROVISIONS OF SECTION 22-64, REGARDING BUSINESS LICENSE TAXES OF THE CODE OF ORDINANCES OF THE CITY OF WARRENSBURG, MISSOURI.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WARRENSBURG, MISSOURI AS FOLLOWS:

Section One. The following categories are deleted from Section 22-64, with all remaining categories left in place, unaltered:

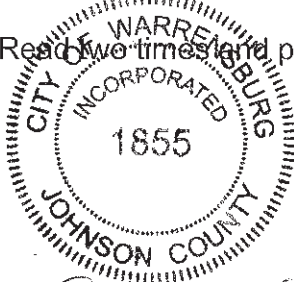
- (3) Barbershops
- (4) Beauty Shops
- (5) Bill Posters
- (6) Boarding Houses
- (7) Bowling Alleys
- (8) Boxing or Wrestling Exhibitions
- (11) Coin-operated Amusement Device Owners, Operators for Profit
- (13) Drayage
- (17) Manufacturers
- (25) Taxicabs
- (27) Truck Distributor(Sales)

Section Two. The provisions of Section 22-64 shall be renumbered to accomplish the removal of the categories listed in Section One above.

Section Three. It is intended that the provisions of this ordinance be incorporated into the Code of Ordinances of the City of Warrensburg.

Section Four. This ordinance shall be in full force and effect from and after its passage.

ORDINANCE NO. 5396

AN ORDINANCE ADOPTING SECTION 22-76 REGARDING INSURANCE REQUIREMENTS FOR CERTAIN OCCUPATIONS OF THE CODE OF ORDINANCES OF THE CITY OF WARRENSBURG.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WARRENSBURG, MISSOURI AS FOLLOWS:

Section One. Section 22-76 of the Code of Ordinances is hereby amended to read as follows:

Sec. 22-76 Insurance Required for Certain Occupations

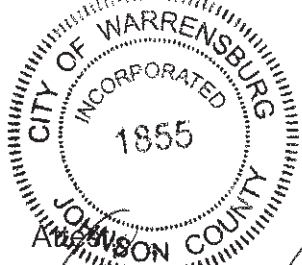
In addition to the other requirements of this Chapter, the following insurance coverages are required for the corresponding occupations. No business or occupation license shall be granted until proof of coverage has been submitted.

- a) For any contractor in the construction industry, proof of workers compensation coverage or an affidavit of exemption shall be provided.
- b) For pest control, proof of public liability coverage of at least \$25,000.00 shall be provided.
- c) For tree service, proof of public liability of at least \$25,000.00 shall be provided.

Section Two. The provisions of Section One of this ordinance shall be incorporated into the Code of Ordinances of the City of Warrensburg.

Section Three. This ordinance shall be in full force and effect from and after its passage.

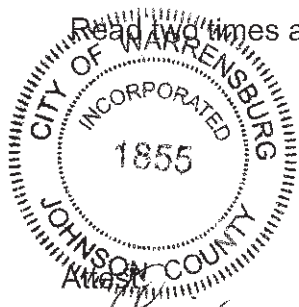
BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WARRENSBURG, MISSOURI AS FOLLOWS:


Section One. Section 4-2 is hereby repealed and reserved for future use.

Section Two. This ordinance shall be in full force and effect from and after its passage.


Section Three. The repeal of Section 4-2 shall be incorporated into the Code of Ordinances of the City of Warrensburg.
